



Report on Shares Acquired under the 2020 Repurchase Plan

In March 2020, Mobile TeleSystems Public Joint Stock Company (the “Company”) announced that its Board of Directors (“BoD” or “the Board”) had approved the repurchase of its shares of common stock and ADSs by means of a share repurchase plan (the “Repurchase Plan”) that authorizes open market transactions, accelerated repurchase transactions and/or privately negotiated transactions in the total aggregate amount of up to RUB 15,000,000,000, which amount includes funds to be used for purchasing the Company’s shares from Sistema Finance. The Company may execute repurchases under the Repurchase Plan pursuant to Rule 10b5-1 under the Securities Exchange Act of 1934, as amended. The Repurchase Plan will be carried out by the Company’s wholly-owned subsidiary Bastion LLC (the “Purchaser”).

Under Russian legislation, MTS is required to disclose any shares acquired by the Company or any of its subsidiaries. The table below shows the number of shares acquired by Bastion LLC under the Repurchase Plan.
