## Report on Shares Acquired under the Repurchase Plan

May 8, 2019

As announced on July 2, 2018, MTS Board of Directors has approved the repurchase of MTS shares of common stock and ADSs by means of a share repurchase plan (the “Repurchase Plan”) that authorizes open market transactions, accelerated repurchase transactions and/or privately negotiated transactions in the total aggregate amount of up to RUB 30,000,000,000, which amount includes funds used for purchasing the Company’s shares from Sistema Finance. The Repurchase Plan comes into effect on July 2, 2018 and is effective for 2 calendar years. The Company will execute the Repurchase Plan under Rule 10b5-1 of the Securities Exchange Act of 1934, as amended. The repurchase of shares and ADSs is carried out via Bastion LLC, 100% subsidiary of MTS.

Under Russian legislation, MTS is required to disclose any shares acquired by the Company or any of its subsidiaries. The table below shows the number of shares acquired by Bastion LLC within the Repurchase Plan.
